WHY?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
WHAT?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:  • Social Security number and employment information  • assets and income  • account balances and risk tolerance

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.  • Our affiliates include companies with the Edelman name including Edelman Financial Services, LLC.			
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.  • Edelman Financial Engines does not share with nonaffiliates so they can market to you.			
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  • Edelman Financial Engines doesn't jointly market.
